ESSER funds helped with the 2022 expenditures -- 480,000; November is a renewal levy - we will review finances after that levy; Nexus appeal - 2019 Shifted Nexus from the general fund, may rescind that resolution at a future time ; Teachers and Tech will move back to 001 - General Fund from ESSER in July 2024. Turf was 600,000 plus, have about 6 more years, collects rental fees - Balance is \$173,000, plus Booster contributions. Need to correct trend before 2025.
