- Plug Smart presented an overview of the project:
 - o Poject initial Completion date October 10; Delays include weather, material shortage
 - Washington roof complete, waiting power and HVAC installation; running two crews
 - Lexington classrooms complete; decking replaced; Began cafeteria roof today; other work next week; finalize power close to end of project.
 - Lexington timeline for completion two weeks;
- · Dr. Shreffler:
 - Lexington 500 sq meters of ceiling needs repaired; increased chance of additional ceiling situations during roof work;
 - BOE should plan and address small portions of abatement at Lexington until complete
- Board Discussion:
 - o Mask Mandates; Safety of Children; Possible causes for ceiling could be humidity, heat, and past leakage
 - o Delay of opening Lexington; abatement; and future asbestos inspection
