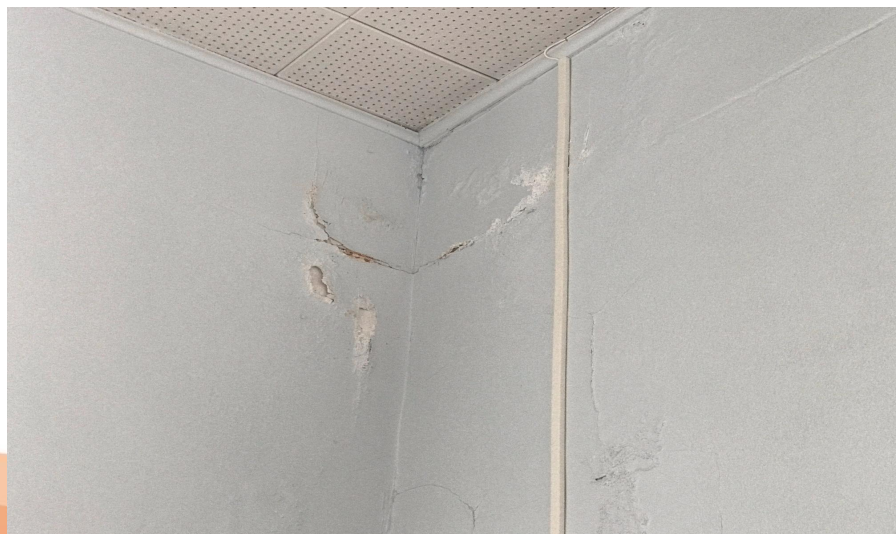

Know the Facts:

- Plan: To build a consolidated elementary school building on the Moulin Avenue campus
- Bond Millage: 3.0 mill property tax bond issue
- Length of Bond Issue: 20 years
- Total Cost: \$29 million
 - **State share: \$14 million (48%)**
 - Local share: \$15 million (52%)
- Cost to owner of a \$100,000 property: Approximately \$10 per month

Primary evacuation points would be easier achieved in reference to your school safety plan. This would also be a good time to consider installing blue light warning systems, updating your entire campus video security system, and to consider a system similar to Navigate for use by first responders.

One new elementary school brings major educational benefits, ensuring that our curriculum and programming offerings stay consistent for all of our students.

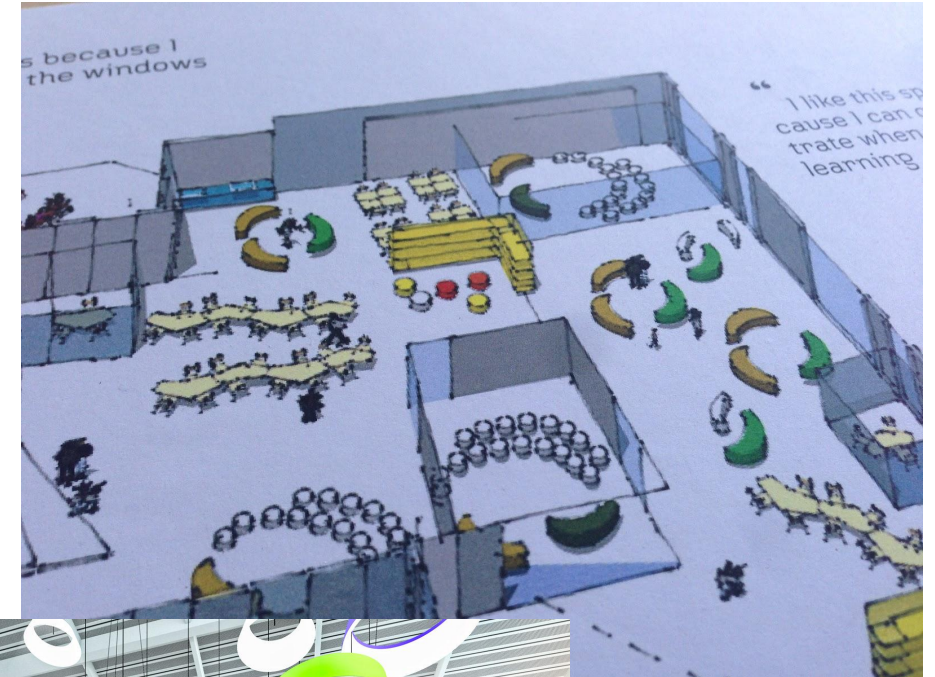

Cost for Bond Issue 11

- 3.0 mills - \$15M Local Share
- The owner of a \$100,000 residential property would pay approximately \$10.00 per month or \$120.00 a year

Consolidating is KEY!

- 3 buildings to 1
- Projected annual net savings of \$500,000 over time through retirements and /or resignations
- Only choice that provides long-term savings!

What we know about NEXUS Pipeline today!

- Not FERC final approved at this time
- Pipeline not through Marlinton school property
NO contract = NO \$'s
- If/when the pipeline is in service, it adds property value
Property value estimate is ~\$87 million
- Property value is re-evaluated annually
Not in service = No value= No tax revenue
- Pipeline impact on bond issue = reduced tax rates for all other taxpayers
3 mills to current tax payers becomes less
